is extended to August 05, 2020, 02:00 p.m. (local time).

In compliance with the relevant decisions and recommendations of the Government of the Republic of Serbia related to prevention of spread of the covid-19 pandemic, the Purchaser shall organize the public opening of the Bids submitted to the Purchaser’s premises as instructed by the relevant Section D of the Bidding Documents via online live stream through Zoom application.

Additionally, by this Modification of the Invitation for Bids, a change in part of the Invitation for Bids published on the official website of the PE “Roads of Serbia” on June 26, 2020, on the UN Development Business (UNDB) online on June 29, 2020 and in Official Gazette of the Republic of Serbia No. 95 from July 03, 2020, is introduced. Namely the part of the original IFB which stipulates the following:

*“All bids must be accompanied by a Bid Security of 7,000 EUR.”*

is herewith modified to read:

“All bids must be accompanied by a **Bid-Securing Declaration.**”

All other information and provisions stated in the original text of the Invitation for Bids shall remain valid.
