SECTION: NEGOTIN (RADUJEVAC) - SRB/BUG BORDER (MOKRANJE)

1. The Republic of Serbia has received financing from the European Investment Bank (EIB) toward the cost of the Road Rehabilitation Project, and intends to apply part of the proceeds toward payments under the contract for Heavy Maintenance (Upgrading) of the State Road IB 33, Section: Negotin (Radujevac) - SRB/BUG Border (Mokranje), from km 187+335 to km 200+254, L=12.919 km, Contract ID No. RRSP/RRW-IB33NM/2021-04. The General Conditions of Contract shall be the “Conditions of Contract for Construction for building and engineering works designed by the employer”, 1st edition 1999, prepared by the Fédération Internationale des Ingénieurs-Conseils (FIDIC). This contract will be jointly financed by the European Investment Bank and Republic of Serbia. Tendering process will be governed by the EIB’s rules and procedures.
2. The Public Enterprise “Roads of Serbia” (hereinafter referred to the Employer) invites sealed tenders from eligible and qualified tenderers for heavy maintenance (upgrading) works consisting of the following:
 - Preliminary works which include removal of shrubs, trees, branches and stumps, demolition of existing elements, cutting asphalt layers;
 - Substructure works which include excavation of humus, mechanical excavation of III and IV category materials, arrangement of the roadbed, construction of embankments, arrangement of the subbase, topsoiling of shoulders, berms and slopes;
 - Superstructure works which include construction of lower and upper unbound base course of crushed stone, pavement construction on access roads, bus stops, parkings; works on improvement of pavement (construction of bituminous bearing course, and construction of wearing asphalt concrete course), as well as placement of concrete curbs and construction of concrete channels;
 - Works on structures (bridge, culverts and walls) which include site cleaning, removal of existing parts of structures, construction or replacement of waterproofing, construction of asphalt layers (levelling course if needed, wearing course, asphalt layer on sidewalk), demolition and reconstruction of the curbs, repair or replacement of the bearing paths, repair or replacement of the expansion devices, repair of the protective layers, bridge drainage, repair of fences and guardrails,

- regulation of hydraulic watercourse profile in the bridge area and any other works if specified by the Main Design;
- Works on drainage system improvement which includes earthworks, works on closed drainage system, supply and installation of manholes, replacement of drainage – discharge system, regulation of watercourses, coating of the inflow and outflow zone of existing culverts, etc;
 - Roadside arrangement and placement of traffic signalization and road furniture;
 - Construction works on rail crossing which includes demolition and removal of pavement structures, demolition of existing elements, earthworks, supply and installation of materials of the upper construction layers of rail, construction of road structure on road crossing;
 - Installation of cable network 1 kV and 10 kV, overhead network 1 kV and 10 kV which includes dismantling overhead networks, supply and installation of materials, electrical works, etc;
 - Installation of public lightening which includes dismantling existing public lighting, supply and installation of materials, electrical works, etc;
 - Relocating the telecommunication cable network which includes supply and installation of materials, etc.

The Works will be performed under traffic with a strong emphasis on maintaining safe conditions for both the flow of traffic and works in progress.

The construction period is 12 months.

The Tenderer should meet the following qualification criteria and capabilities:

Financial requirements

- Submission of audited balance sheets or, if not required by the law of the Tenderer's country, other financial statements acceptable to the Employer, for the last 5 (five) years to demonstrate the current soundness of the Tenderers financial position and its prospective long term profitability. In the case of JV, each partner must meet the requirement.
- Minimum average annual construction turnover of 1,300,000,000 (one billion three hundred million) RSD equivalent, calculated as total certified payments received for contracts in progress or completed, within the last 5 (five) years. In the case of JV, all partners combined must meet the requirement, the lead partner must meet 60% (sixty percent) of the requirement and each other partner must meet 30% (thirty percent) of the requirement.
- The Tenderer must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement: min. 250,000,000 (two hundred fifty million) RSD equivalent. In the case of JV, all partners combined must meet requirement, the lead partner must meet 60% (sixty percent) of the requirement and each other partner must meet 30% (thirty percent) of the requirement.

Experience requirements

- General experience – Experience under contracts in the role of contractor or management contractor for the last 5 (five) years prior to the tender submission deadline, and with activity in at least 9 (nine) months in each year. In the case of JV, each partner must meet the requirement.
- Specific experience:
 - Participation as contractor or management contractor in at least 2 (two) contracts, within last 5 (five) years, each with a value of at least 500,000,000 (five hundred million) RSD equivalent that have been successfully and substantially completed and that are similar to the proposed Works. In the case of JV, all partners combined must meet the requirement, the lead partner must meet the requirement for at least 1 contract out of 2.
 - For the above or other contracts executed during the stipulated period, a minimum experience in the following key activities: production and laying of asphalt mixtures (asphalt concrete and bituminous base) not less than 30,000 tones/year in the last 3 (three) years calculated as average during the specified period. In the case of JV, all partners combined must meet the requirement.

Above and all other qualification requirements related to the eligibility, litigation history, and technical capabilities are specified in the Section III Evaluation and Qualification Criteria of the Tender Documents.

3. Tendering will be conducted through the International Procurement Open Procedures specified in accordance with “Guide to Procurement for projects financed by the EIB” issued in September 2018 (“Procurement Guidelines”) available at the following link: <https://www.eib.org/en/publications/guide-to-procurement>. Tendering is open to all eligible tenderers as defined in the Procurement Guidelines. In addition, please refer to paragraph 1.5 setting forth the Bank’s policy on conflict of interest.
