## **INVITATION FOR TENDERS (IFT)**

# HEAVY MAINTENANCE (UPGRADING) OF THE STATE ROAD IB 22 SECTION: RAŠKA (K. MITROVICA) - NOVI PAZAR (BANJA) FROM KM 236+001 TO KM 253+891 L=17.890 KM

#### CONTRACT ID NO. RRSP/RRW-IB22RNP/2021-06

- 1. The Republic of Serbia has received financing from the European Investment Bank (EIB) toward the cost of the Road Rehabilitation Project, and intends to apply part of the proceeds toward payments under the contract for Heavy Maintenance (Upgrading) of the State Road IB 22, Section: Raška (K. Mitrovica) Novi Pazar (Banja), from km 236+001 to km 253+891, L=17.890 km, Contract ID No. RRSP/RRW-IB22RNP/2021-06. The General Conditions of Contract shall be the "Conditions of Contract for Construction for building and engineering works designed by the employer", 1st edition 1999, prepared by the Fédération Internationale des Ingénieurs-Conseils (FIDIC). This contract will be jointly financed by the European Investment Bank and Republic of Serbia. Tendering process will be governed by the EIB's rules and procedures.
- 2. The Public Enterprise "Roads of Serbia" (hereinafter referred to the Employer) invites sealed tenders from eligible and qualified tenderers for heavy maintenance (upgrading) works consisting of the following:
  - Preliminary works which include removal of excessive vegetative material and waste, demolition of road elements on access roads (curbs and pavement), demolition and removal of elements of the damaged constructions, surface preparation of the existing pavement for application of new layers (milling of the existing pavement, repair of wide cracks) and displacement of existing TT and optical installations;
  - Substructure works which include excavation of ditches, construction of stabilized shoulders, topsoiling of shoulders and other surfaces, and earth works on construction of asphalt access roads and bus stops;
  - Superstructure works which include pavement construction on access roads, works on improvement of pavement (construction of bituminous bearing course, and construction of wearing asphalt concrete course), as well as placement of concrete curbs and construction of gutters;
  - Works on structures (bridge, culverts and retaining walls) which include milling of the existing asphalt layer, construction or replacement of waterproofing, construction of asphalt layers (levelling course if needed, wearing course, asphalt layer on sidewalk), demolition and reconstruction of the curbs, repair or replacement of the bearing paths, repair or replacement of the expansion devices, repair of the protective layers, bridge drainage, repair of fences and guardrails, regulation of hydraulic

- watercourse profile in the bridge area, repairing of existing and retaining walls and gabions and any other works if specified by the Main Design;
- Works on drainage system improvement which includes earthworks, works on closed drainage system, supply and installation of manholes and separators, replacement of drainage – discharge system, etc;
- Roadside arrangement and placement of traffic signalization and road furniture;
- Public lighting works which include procurement of main material (light for functional lighting with LED sources, etc) works on public lightening construction, trimming and crushing asphalt concrete surfaces and laying the cables, construction of a concrete foundation and testing the cables.

The Works will be performed under traffic with a strong emphasis on maintaining safe conditions for both the flow of traffic and works in progress.

The construction period is 16 months.

The Tenderer should meet the following qualification criteria and capabilities:

#### Financial requirements

- Submission of audited balance sheets or, if not required by the law of the Tenderer's country, other financial statements acceptable to the Employer, for the last 5 (five) years to demonstrate the current soundness of the Tenderers financial position and its prospective long term profitability. In the case of JV, each partner must meet the requirement.
- Minimum average annual construction turnover of 1,500,000,000 (one billion five hundred million) RSD equivalent, calculated as total certified payments received for contracts in progress or completed, within the last 5 (five) years. In the case of JV, all partners combined must meet the requirement, the lead partner must meet 60% (sixty percent) of the requirement and each other partner must meet 30% (thirty percent) of the requirement.
- The Tenderer must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement: min. 310,000,000 (three hundred ten million) RSD equivalent. In the case of JV, all partners combined must meet requirement, the lead partner must meet 60% (sixty percent) of the requirement and each other partner must meet 30% (thirty percent) of the requirement.

#### Experience requirements

- General experience Experience under contracts in the role of contractor or management contractor for the last 5 (five) years prior to the tender submission deadline, and with activity in at least 9 (nine) months in each year. In the case of JV, each partner must meet the requirement.
- Specific experience:
  - Participation as contractor or management contractor in at least 2 (two) contracts, within last 5 (five) years, each with a value of at least 790,000,000 (seven hundred ninety million) RSD equivalent that have been successfully and substantially completed and that are

- similar to the proposed Works. In the case of JV, all partners combined must meet the requirement, the lead partner must meet the requirement for at least 1 contract out of 2.
- For the above or other contracts executed during the stipulated period, a minimum experience in the following key activities: production and laying of asphalt mixtures (asphalt concrete and bituminous base) not less than 40,000 tones/year in the last 3 (three) years calculated as average during the specified period. In the case of JV, all partners combined must meet the requirement.

Above and all other qualification requirements related to the eligibility, litigation history, and technical capabilities are specified in the Section III Evaluation and Qualification Criteria of the Tender Documents.

- 3. Tendering will be conducted through the International Procurement Open Procedures specified in accordance with "Guide to Procurement for projects financed by the EIB" issued in September 2018 ("Procurement Guidelines") available at the following link: <a href="https://www.eib.org/en/publications/guide-to-procurement">https://www.eib.org/en/publications/guide-to-procurement</a>. Tendering is open to all eligible tenderers as defined in the Procurement Guidelines. In addition, please refer to paragraph 1.5 setting forth the Bank's policy on conflict of interest.
