

Instructions for filling out the request for issuing bill for paid toll

When creating a request for issuing bill for paid toll, the applicant is obliged to use a document downloaded from the official website of the LLC "PUTEVI SRBIJE". The Request is formed as a table in which fields data indicated in the receipts (slips) obtained upon transactions performed at toll stations need to be entered.

File naming/creation

Downloaded files need to be named in the following format:

1. **RequestEuroVATtoll_000000000_YYYYMMDD00** – Request for VAT refund based on paid toll
2. **RequestEuroVATrecharge_000000000_YYYYMMDD00** - Request for VAT refund based on value of TAG device recharge at toll stations

000000000 – Taxpayer Identification Number (TIN) (TIN is a 9-digit code)

YYYYMMDD – year/month/day of request creation

00 – reference number of request within the same day (each request submitted on the same day needs to be assigned a different reference number, or otherwise it may not be recognized by the program)

Important: The request shall be formed/named by precise following of the abovementioned Instruction, or the system may not accept it for further processing. No other data except those specified above shall be entered into the file name.

Completing the table:

Above the table there are blank fields which need to be filled with "correct" data about the applicant, their headquarters and

company's address, as well as Tax Identification Number (TIN).

Example:

Name of buyer-applicant:	LLC "Putevi Srbije" Belgrade
Headquarters and address:	Belgrade, Bulevar kralja Aleksandra 282
TIN:	10426045

Upon entering basic data, it is necessary to specify in blank fields the time period for which this request is submitted (note: accounting period is 30 days).

Example:

The large table consists of columns which need to be filled with data indicated in the receipt (slip). Every data required in the table needs to be entered in order to properly complete the request for invoicing VAT refund. If the receipt does not include road section or motorway name, leave this entry field blank. **The applicant submitting a requestVATrecharge shall not fill columns number 6 and 7. The applicant submitting a requestVATtoll shall not fill columns number 5 and 6.**

Certain columns have drop/down menu for more precise data entering.

The Table is limited to 300 rows. If the applicant possesses a greater number of receipts (slips), it is necessary to make a greater number of requests and address each request with separate reference number. **The Table shall not be changed or shortened in case of a smaller number of receipts for entering.**

The table shall be completed and sent in **.xlsx** (excel) format as indicated at the official web page of the PE Roads of Serbia.

Notes:

- Maximum email size is 10MB.
- In case that upon submission of request the following automatic notification is received: "Your request does not contain receipt specification in prescribed .xlsx format. This mail shall be considered as an attachment to the submitted request", make sure that the table and name of document are properly created. The system automatically rejects the request in case it's not created as prescribed in instructions.
- In case some data on the receipt are illegible, a complaint shall be submitted in the same manner as the Request for issuing bill for paid toll with indication (as an e-mail subject line) "Complaint". Scanned slips at issue shall be attached to this request.
- Files support software package „Microsoft Office 2007" and newer versions.
- Clients using software package Microsoft Office 2003 or older versions and facing issues when opening files, may solve this problem by downloading additional Microsoft Office compatibility pack which they can download free of charge at: www.microsoft.com

The Request for issuing bill for paid toll in electronic form and scanned slips shall be sent to the e-mail: racun.pdv@putevi-srbije.rs

In addition, printed copy of completed request and copies of the receipts (slips) shall be submitted by mail to the LLC "Putevi Srbije", Sector for Toll Collection, Ljube Čupe 5, Belgrade.
